BOOKING CONDITIONS

DEPOSITS:

A minimum non-refundable deposit of \$440.00 per person must be lodged with the booking agent before any booking is made. Liveaboard dive vessels will require a further deposit the amount of which will be advised at time of booking.

FINAL PAYMENTS:

Final payments are due 45 days prior to travel excepting liveaboards which require payment a minimum of 60 days prior to departure and may also require installment payments. Individual operators may have their own payment conditions which may vary from standard payment deadlines.

Where other discount airfares are utilised, different conditions will apply for final payment of total package price. Full details are available from your booking agent or Allways Dive Expeditions.

Payments made later than due date on Invoice will incur a late fee of \$50.00 per person.

A late fee of \$100.00 is payable for Liveaboards where the payment is not made by the due invoiced date.

CANCELLATIONS AND REFUNDS:

ALL DEPOSITS ARE NON REFUNDABLE AND NON TRANSFERABLE.

Where Final Payment has been received for travel under 60 days, no refund is applicable. Some operators have individual booking/cancellation requirements please ensure you check full details with your travel agent or Allways Dive Expeditions at the time of booking.

ERRORS AND OMISSIONS:
